Without insurance, dental care can be expensive. A porcelain crown could cost around \$1,192<sup>1</sup> or more depending on where the procedure is performed. For \$5.68<sup>2</sup> or less a day, an individual may purchase a Personal Dental plan for an entire family and get coverage for preventive, basic and major services, and access to discounts through a PPO network.

Preventive care on the Personal Dental plans is covered at 100% to 80% of the usual and customary charge or at a reimbursable amount. A \$50 yearly deductible applies to basic and major services only. Individuals may select an indemnity plan that increases coverage for every year up to the third year; or select a Scheduled Reimbursement plan, which provides an easy to follow list of reimbursements for each covered dental procedure.

Personal Dental is currently available for California residents through the BEST Employers Association website, and starting with December 1, 2011 effective dates.
