The following exclusions are not covered.

- Services provided by anyone other than a doctor of medical dentistry or a doctor of dental surgery, unless a licensed hygienist performs the services under the direction of a doctor of medical dentistry or a doctor of dental surgery, or a denturist.
- Services received while on active duty with a military service of any country or international organization.
- Services needed because of voluntary participation in a riot or insurrection or the commission of a felony.
- Services needed as a result of a work related injury or illness, whether or not covered under Workers' Compensation.
- 5. Services provided by an employer.
- 6. Services started before the effective date. Examples of excluded services under this paragraph include but are not limited to obtaining an impression for an appliance or a modification of one before coverage; preparing a tooth for a crown, bridge or other lab fabricated restorations before coverage; opening a pulp chamber for root canal therapy before coverage.
